If this consent is approved, the individual driving a student to off campus activities is not considered an agent of Eastmont School District in any respect or for any purpose. Parents/Guardians and adult students agree to hold Eastmont School District harmless of any claim involving any transportation to off-campus events and activities. Parent/Guardians also understand they are solely responsible for any and all required insurance and medical coverage.

Please note it is illegal for any driver under the age of 18 to have passengers under the age of 20, during their first six months of having a driver's license. It is also illegal for minor drivers to have more than 3 passengers under the age of 20.
