## Eastmont School District—Section 504

**PURPOSE**: As a parent/guardian of a child with a Section 504 Plan or child suspected of needing Section 504 accommodations, the school district is required to provide you with prior written notice whenever it **proposes or refuses** to initiate or change the identification, evaluation, educational placement, or provision of a free appropriate public education to your child. This notice should be given to you after a district makes a decision and before action is taken on the decision. The notice should be given to you in a reasonable amount of time before the district takes action.
